**Meeting Minutes: September 15, 2018**

The meeting was convened at 11:30 AM by the Chairman, Dr. Jayashree Patil, in the IQAC Room, who welcomed all members and outlined the agenda for the session. The meeting began with a discussion of recent awareness programs on the Prevention of Sexual Harassment (PoSH) at the workplace. Dr. Ganpathi T, representing the teaching staff, emphasized the importance of spreading awareness about legal rights among female students and staff. Smt. Sarika and Smt. Kavita Mana, non-teaching staff members, raised concerns regarding the need for better communication of policies to administrative staff. Student representatives, Sayeed Ismail Quadri and Sachin Kulkarni, reported that students were unclear about how to approach the committee with complaints. Adv. Renuka, the legal advisor, suggested holding workshops and interactive sessions to educate both students and staff about the procedures and laws related to sexual harassment. The committee resolved to organize a series of workshops in the coming months, promote an open-door policy for complaints, and ensure more visibility of the complaint mechanism throughout the campus. Additionally, Dr. Jayashree Patil proposed a periodic review of the complaints received to ensure timely and fair resolutions.

**Meeting Minutes: September 12, 2019**

The Anti-Sexual Harassment cum ICC met at 11:30 AM, chaired by Dr. Jayashree Patil. The agenda centered around complaints received from the non-teaching staff and discussions on preventive measures against workplace harassment. The members, including Dr. Ganpathi T and Smt. Sarika, noted that while no formal complaints had been lodged, there were concerns regarding the lack of awareness about the complaint process. Smt. Jyoti Patil, the NGO representative from Bhavani Mahila Mandal, Bhalki, proposed holding targeted training sessions for the non-teaching and administrative staff to better inform them about their rights and the resources available. Student representatives highlighted the need for similar workshops to be held for the student body, particularly first-year students, to ensure they are familiar with campus safety protocols. Adv. Renuka outlined the legal framework protecting individuals against harassment and recommended more visible posters and banners across the campus displaying helpline numbers and committee contact information. The meeting concluded with the decision to host awareness programs biannually and increase the frequency of committee meetings to promptly address any issues.

**Meeting Minutes: October 22, 2020**

Held at 11:30 AM in the IQAC Room, the meeting was called to order by Dr. Jayashree Patil. The members discussed the challenges posed by the COVID-19 pandemic, particularly the rise in online interactions, and the importance of maintaining awareness about sexual harassment in virtual spaces. Dr. Ganpathi T stressed that the use of online classes and communication platforms must include clear guidelines for respectful behavior. Smt. Kavita Mana and Smt. Sarika discussed concerns raised by staff regarding inappropriate messages and the need for stricter monitoring. Smt. Jyoti Patil suggested incorporating modules on online harassment as part of the virtual orientation for students. The committee agreed to update the anti-sexual harassment policy to address issues related to online interactions. Adv. Renuka emphasized that any harassment, whether physical or virtual, should be reported to the committee immediately, and steps would be taken to safeguard all members of the college community. The meeting ended with a resolution to draft guidelines on appropriate conduct in virtual classrooms and hold a virtual awareness session for students and faculty.

In the meeting held at 11:30 AM, the committee, chaired by Dr. Jayashree Patil, convened to review complaints from the previous academic year. The members discussed the lack of formal complaints but expressed concerns about informal reports of inappropriate behavior between students. Dr. Ganpathi T proposed increasing peer counseling initiatives to encourage more open communication among students. Smt. Jyoti Patil, representing the Bhavani Mahila Mandal, suggested forming a student sub-committee to act as first points of contact for their peers who may feel uncomfortable approaching faculty members directly. The student representatives, Sayeed Ismail Quadri and Sachin Kulkarni, supported this initiative, agreeing that it would encourage more students to come forward with their concerns. The committee also discussed the need for refresher workshops for faculty and staff to ensure they are updated on their roles and responsibilities in preventing and addressing harassment. It was decided that an annual survey would be conducted among students and staff to assess the effectiveness of the committee's actions and gather feedback.

S V Malshetty, Librarian, who welcomed all members and outlined the key agenda items. The issues raised included delays in the availability of library books, the need for improved toilet cleanliness, irregular drinking water supply, and pending examination revaluation results. Dr. Jayashree Patil emphasized the importance of addressing the hygiene concerns in toilets and ensuring timely cleaning, especially during examination periods. Prof. R V Gouda proposed setting up a schedule for regular maintenance and better communication with the housekeeping staff. Dr. Ganapathi T discussed the need for faster response times for student revaluation results. #### **Meeting Minutes: September 18, 2019**

In the meeting chaired by Sri. S V Malshetty at 11:30 AM, the members, including Dr. Jayashree Patil, Prof. R V Gouda, and Dr. Ganapathi T, reviewed grievances related to the previous year. The major concerns voiced by students included the shortage of specific textbooks in the library, improper maintenance of toilet facilities, and the lack of drinking water during peak summer months. Furthermore, the delay in receiving revaluation results from the examination office was causing anxiety among students. After deliberation, the members agreed on several measures: additional textbooks would be requested from suppliers, a system for timely toilet cleaning would be established with daily checks, new drinking water stations would be installed near classrooms, and the examination department would be urged to expedite revaluation result processes. Grievances were largely centered around access to library resources during the lockdown, along with complaints regarding the cleanliness of toilets and inconsistencies in drinking water supply as the college reopened for offline classes. The delay in the release of revaluation results from the previous academic session was also discussed. Dr. Jayashree Patil recommended enhancing online library services to allow students to access books digitally, while Prof. R V Gouda suggested staggering the cleaning schedules to maintain hygiene in light of increased safety protocols. The committee agreed to expedite pending revaluation results and provide better coordination with the housekeeping and maintenance staff to ensure the timely availability of water and proper sanitation.

#### Meeting Minutes: July 30, 2021

At 11:30 AM, the meeting was convened by Sri. S V Malshetty, who highlighted the grievances received from students during the reopening phase after the second wave of COVID-19. Issues included delayed replenishment of library books, infrequent toilet cleaning, poor drinking water availability, and the backlog of revaluation results from the previous semester. The members, including Dr. Jayashree Patil and Prof. R V Gouda, agreed that post-lockdown adjustments were necessary, particularly in addressing student frustrations over the limited availability of academic resources. Dr. Ganapathi T proposed engaging third-party suppliers to ensure a regular supply of essential library materials and implementing stricter sanitation schedules. It was also decided that a formal request would be submitted to the examination section to clear pending revaluation results within the next two weeks, thus alleviating the anxiety among students.

#### Meeting Minutes: September 10, 2022

In the final meeting of the academic year, Sri. S V Malshetty opened the discussion at 11:30 AM, reiterating the need to address unresolved grievances related to the delayed provision of library resources, inadequate toilet maintenance, and irregular access to drinking water. The continued delays in examination revaluation results were a significant concern, with many students requesting a more transparent and efficient process. Dr. Jayashree Patil recommended closer collaboration with the examination office to ensure faster turnaround times for revaluation results. The committee, after careful review, decided to immediately act on these grievances by procuring the necessary library books, enhancing the maintenance schedule for toilets, installing additional water coolers on campus, and advocating for stricter timelines with the examination section.
